



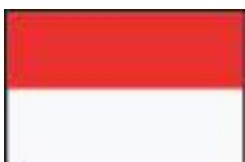

Indonesia is a country in Southeast Asia and Oceania, between the Indian and Pacific oceans of over 17,000 islands, including Sumatra, Java, Sulawesi, and parts of Borneo and New Guinea. Indonesia is the world's largest archipelagic state and the 14th-largest country by area 735 thousand square miles. With over 280 million people, Indonesia is the world's fourth-most-populous country and the most populous Muslim-majority country. Islamic University of Indonesia (*Universitas Islam Indonesia* abbreviated as UII) is a national private university in Yogyakarta, Indonesia established Higher School by political figures Dr Mohammad Hatta (1902-1980) and others developed into a university in 1947, a Indonesian statesman, nationalist, and independence activist who served as the country's first vice president as the first president of Indonesia, Sukarno, fought for the independence of Indonesia from the Netherlands. Historically, UII is the first private university in Indonesia established after Indonesian independence.



Holistic Curriculum: The Faculty of Business and Economics provides holistic and multi-disciplinary higher and educational, which aim to develop all capacities of human beings-intellectual in economic, business, social, moral, and technology. More than 98,000 UII (2024) shows has a staff of 769 faculty, 24,391 undergraduates, and 3,031 postgraduates. Out of the 25 study programs currently available at UII over 70% have obtained "A" accreditation for their study programs. The accomplishments there are currently 17 UII study programs by received *Unggul* accreditation.



UII now has grown into a great place for learning. Located historically, UII is the first private university in Indonesia established after Indonesian independence. Located at the northern outskirts of Yogyakarta, the heart of Javanese culture, the main campus, overlooking the stunning of Merapi, is a perfect place to study. Learning is discovering within oneself. Programs of 4 doctoral, 1 master, 3 professional, 25 undergraduate, and 4 diploma covering a wide spectrum of knowledge.
